1. EQUIPMENT MAINTENANCE/ REPAIRS ARE ON- GOING.
2. MONTHLY BRANCH PICK UP.
3. FIRST ROUND OF ROADSIDE MOWING WAS COMPLETED.
4. COLD PATCH ROADS-MATERIAL USED 1 TON.
5. SIGN REPAIRS/ REPLACEMENTS (6)- DANNE RD. (SPEED/WEIGHT), OFFNER RD. (CROSS T), KLEMME RD. (SPEED), WOODLAWN AVE. (SPEED), OLD POST RD. (CROSS TRAFFIC), AND KENT AVE. (STREET).
6. CULVERT REPLACEMENTS, TOTAL (2)- OAK CT. AND FOREST VIEW LN.
7. DITCHWORK COMPLETED ON TIMBERLINE TR., TIMBEREDGE CT., AND CHALLAS DR.
8. ROADSIDE MOWING WITH BOOM MOWER IS ON-GOING.
9. APPLIED RIP RAP IN WASHOUTS ALONG THE ROAD ON LAKESIDE CT., STATELINE RD., AND ANNE LN.
10. TREE TRIMMING/ REMOVAL WAS COMPLETED ON OLD POST ROAD.
11. CREWS WENT OUT TO REMOVE TREES BLOCKING THE ROADS DUE TO STORMS ON 6/10 AND 6/11 ON CHALLAS DR., RAYMOND DR., AND NORFOLK AVE., ON 6/17 ON GOODENOW RD., ON 6/22 ON WOODLAWN AVE., ON 6/23 ON VERA LN., ON 6/25 ON OLD POST RD., AND ON 7/3 ON DEER RUN TR., AND LAKESIDE CT.
12. BARRICADES FOR HIGH WATER ON ROADS WERE PLACED AT MANY LOCATIONS ON 6/11. ROADS THAT WERE TEMPORARILY CLOSED DUE TO FLOODING WERE BURVILLE RD. AT EXCHANGE ST. AND OLD POST RD., FLOODING REMAINED AT MANY LOCATIONS DURING THE WEEKEND OF 6/13 AND 6/14.
